

**OFFICIAL RULES AND REGULATIONS OF THE
“WINSPORT SKI & SNOWBOARD RAIL JAM JUNIOR PHOTOGRAPHER CONTEST”**

WinSport’s 2026 End of Season “WinSport Ski & Snowboard Rail Jam Junior Photographer Contest” is provided by the Calgary Olympic Development Association, operating as WinSport (“WinSport”).

1. **Agreement:** These Rules and Regulations (the “Rules”) are the official rules and regulations of the WinSport Ski & Snowboard Rail Jam Junior Photographer Contest on **March 28, 2026** (Snowboard) and **March 29, 2026** (Ski) (the “Event”) and are governed by WinSport. The act of entering the Event constitutes acceptance of these Rules.

2. **Entry:** Individuals (each an “Entrant”) who meet the eligibility criteria set out below may enter the Junior Photographer Contest by registering for participation. Entrants may opt out of participating in the contest at any time by choosing not to submit a photo as set out in Section 6, below.

3. **Event Waiver Requirement: A Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement (“Waiver”) must be completed by each Entrant’s parent/legal guardian prior to participation in the Event. If the applicable Waiver is not completed, participation in the Event access to WinSport’s Event facilities will not be permitted.** The Waiver will be available for completion during the registration process, and a copy is available for preview, prior to registration, on WinSport’s Events and Registration webpage.

4. **Divisions to photograph:** Those Junior Photographers registered to participate will have the opportunity to photograph the Open divisions (“Divisions”) on the date the Entrant has registered for. **There will be a maximum of 15 Entrants accepted for this competition:**

- Open Female (Ages 13+) Snowboard (March 28)
- Open Male (Ages 13+) Snowboard (March 28)
- Open Female (Ages 13+) Ski (March 29)
- Open Male (Ages 13+) Ski (March 29)

5. **Eligibility:** The Event is open to any individual who has reached the age of 12 on March 28, 2026, and who has not reached the age of 18 on March 28, 2026, except WinSport employees, employees’ immediate family members and anyone living with any WinSport employee. “**Immediate family**” means spouses, parents, children, siblings and their respective spouses, regardless of whether they reside in the same household. There will be a maximum of 15 Entrants accepted for this competition. Eligible Entrants are accepted on a first-come-first served basis, and can attend one or both competition days. There is no fee to register.

6. **Skill Contest:** The Event is a photography skill competition. Each Entrant will submit one photo to WinSport for judging purposes. WinSport will then post each photo on our Instagram account (<https://www.instagram.com/winsportcanada/>). WinSport followers will be asked to vote on their favourite photo. The photos which receive the most votes by 3 p.m. on Friday, April 3, 2026, will be deemed the winner(s). In the event of a tie at 3 p.m. on Friday, April 3, 2026, the two photos receiving the same number of votes will be reposted until 3 p.m. on Monday, April 6, 2026 at 3 p.m. and the photo receiving the most votes by this time will be deemed the winner.

7. **Prize:** There are three (3) prizes available:

- The Entrant whose photo receives the most votes, will be awarded a **\$100 Gift Card from The Camera Store (802 11 Ave SW, Calgary, AB T2R 0E5), along with a \$50 WinSport Gift Card.** The second and third-place finishers will each receive a \$50 WinSport Gift Card.

The Prize Winners agree to accept their Prize as-offered and as-is. Each Winner must claim their Prize by **May 15, 2026**, at 4:30 p.m. If any Winner does not collect their Prize by that time, that Winner's Prize will be forfeited. If any Winner opts out of the Competition after the declaration of winners, then the Prize corresponding to that Winner's placement will not be awarded to any person (e.g. if the second-place finisher opts out of the Event, the second-place cash prize will not be awarded).

WinSport reserves the right to substitute any Prize or portion of the Prize with a prize of equal or greater value. All Prizes are awarded as-is and no warranties or guarantees are implied or expressed.

8. Award of Prize to Minor: As the Winner is a minor under the age of 18, their Prize will be lawfully delivered on behalf of the minor to the minor's parent or legal guardian.

9. Code of Conduct: For the safety and enjoyment of all, Entrants and other users of WinSport's facilities are required to follow the *WinSport Code of Conduct*.

10. Prohibitions: WinSport may, in its sole discretion, prohibit any person from entering the Event whom it believes to be abusing the Rules, including the WinSport Code of Conduct. Any Entrant who violates any part of these Rules will be banned from the Event. Any Winner who violates any part of these Rules may have their Prize withheld at WinSport's sole discretion.

11. Release of Liability: By entering the Event, the parent/legal guardian of each Entrant hereby releases, and agrees to indemnify, defend and hold harmless, WinSport and its directors, officers, employees, instructors, guides, agents, representatives, volunteers, independent contractors, subcontractors, sponsors, insurers, successors and assigns (collectively, the "**Releasees**") from any and all liability for any loss, harm, damages, cost or expense arising out of participation in the Event including, but not limited to, participation in any Event-related activity or the acceptance, use, or misuse of any Prize, including but not limited to costs, injuries, losses related to personal injuries, death, damage to or loss or destruction of property.

12. Privacy/Use of Personal Information, Image and Likeness: By participating in the Event, each Entrant (or their parent/legal guardian in the case of minors): (i) grants WinSport the right to use their name, mailing address, telephone number, and e-mail address ("Personal Information") for the purpose of administering the Event, including but not limited to contacting and announcing the Winners; and (ii) acknowledges that WinSport may disclose their Personal Information to third-party agents and service providers of WinSport in connection with any of the activities listed above. WinSport will use the Entrant's Personal Information only for identified purposes and protect the Entrant's Personal Information in a manner that is consistent with the *Personal Information Protection Act* of Alberta.

13. Use of Image or Likeness: By participating in the Event, each Entrant (or their parent/legal guardian in the case of minors): also grants to WinSport the unconditional and perpetual right to copy, reproduce, store, transmit, publish, and/or otherwise use and reuse taped footage, images, photographs, appearance, voice and interviews of the Entrant for any WinSport marketing, promotion, advertisement, collateral material and media-related purposes, *including for the accompanying Junior Photographer photo event which will be run in conjunction with the Event*.

14. Termination: WinSport reserves the right, in its sole discretion, to terminate the Event, in whole or in part, and/or modify, amend or suspend the Event, and/or these Rules in any way, at any time, for any reason without prior notice.

15. Law: The Event is subject to applicable federal, provincial and municipal laws and regulations. The Rules are subject to change without notice in order to comply with any applicable federal, provincial and municipal laws or the policy of any other entity having jurisdiction over WinSport. All issues and questions concerning the construction, validity, interpretation and enforceability of these Rules or the rights and



obligations as between the Entrant and WinSport in connection with the Event shall be governed by and construed in accordance with the laws of the Province of Alberta including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws. Any disputes relating to this Event will be within the exclusive jurisdiction of the Courts of the Province of Alberta.

16. **Language Discrepancy:** In the event of any discrepancy or inconsistency between the terms and conditions of these Rules and disclosures or other statements contained in any Event-related materials, including but not limited to the Event entry forms, or point of sale, television, print or online advertising, the terms and conditions of these Rules shall prevail, govern and control.

17. **Other:** The Event and these Rules are governed by the laws of Alberta and the laws of Canada applicable therein. WinSport reserves the right to cancel or modify the Event or these Rules at any time without notice. All Prizes must be accepted as awarded. ***WinSport is not liable for any inability to process entries, or any errors, damage or negligence that may arise in connection with the Event, including technical failures, virus, website down-time, human error or property damage incurred by any Entrant.***
