RENTAL AGREEMENT

- I accept full responsibility for the care of any rental equipment (the "Equipment") rented during WinSport's 2025-2026 Ski and Snowboard Season and I agree to pay WinSport for any damage to the Equipment, unless covered by WinSport's Equipment Damage Protection Plan purchased by me.
- I agree to return the Equipment in a clean, undamaged condition to avoid any additional charges. I further agree to pay WinSport for the full retail value of the Equipment if not returned by the end of each rental period or damaged beyond repair. I understand that I will be required to provide my credit card number as security for the Equipment and I hereby authorize WinSport to charge my credit card for any damage or loss.
- I am familiar with the proper use of the Equipment. I understand that the rental technicians are able to answer questions I may have as to the proper use of the Equipment.
- DOWNHILL SKI EQUIPMENT ONLY** I will provide the User's accurate height, weight, age, or skier type where required. (This information is required in order to properly adjust the ski boot/binding settings.) I agree to verify that the settings appearing in the visual indicator windows on the bindings correspond with the settings provided by WinSport. I acknowledge that WinSport will be relying on the information provided by me to provide the Equipment for the duration of WinSport's 2025-2026 Ski and Snowboard Season. I agree that if any of the Equipment User's height, weight, age, or skier type changes during WinSport's 2025-2026 Ski and Snowboard Season, I will immediately inform WinSport prior to receiving the Equipment.
- I acknowledge that this Release Agreement shall apply to all Equipment rentals and ski and snowboard activities during WinSport's 2025-2026 Ski and Snowboard Season.

ASSUMPTION OF RISKS

I am aware that participating in skiing and snowboarding will expose me to many risks, dangers and hazards that could result in injury, psychological damage, paralysis, brain injury, death, property damage or loss, including loss to other third parties. I am aware that injuries are a common and ordinary occurrence in these activities.

ALPINE SKIING I understand that the ski boot/binding system may not release during every fall or may release unexpectedly. The ski boot/binding system is no guarantee that the Equipment User will not be injured.

SNOWBOARDING I understand that the boot/binding system is not designed or intended to release and will not release under normal circumstances. I understand that as the boot/binding system is a non-release system, this system will not reduce the risk of injury during a fall and will increase the risk of not surviving an avalanche.

HELMETS I understand that a helmet designed for snow sports activities may reduce the risk of some types of head injuries at slower speeds; however, serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I AM AWARE OF AND FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGERS AND HAZARDS ASSOCIATED WITH SKIING AND SNOWBOARDING AND WITH THE USE OF THE EQUIPMENT, AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE, OR LOSS RESULTING THEREFROM. I FURTHER AGREE THAT MY PARTICIPATING IN SKIING AND SNOWBOARD AND MY USE OF THE EQUIPMENT IS PURELY VOLUNTARY AND I ELECT TO PARTICIPATE DESPITE THESE RISKS, DANGERS AND HAZARDS.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the rental of the Equipment, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES, and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury, including death, that I may suffer, or that my heirs, next of kin, executors, administrators, assigns and representatives may suffer, resulting from or arising out of any aspect of my use of the Equipment or skiing and snowboarding, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS’ LIABILITY ACT, RSA 2000, c O-4, or in respect of the design, manufacture, installation, maintenance, selection or adjustment of the Equipment. I UNDERSTAND THAT NEGLIGENCE INCLUDES INCOMPLETE OR IMPROPER INSTRUCTIONS AND FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM, OR WARN ME OF, THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH SKIING AND SNOWBOARDING AND WITH THE USE OF THE EQUIPMENT;

2. TO HOLD HARMLESS, INDEMNIFY AND DEFEND THE RELEASEES from any and all liability for any property damage, loss, or personal injury to any third party resulting from my use of the Equipment and my skiing and snowboarding;

3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity;

4. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of Alberta and no other jurisdiction;

5. Any litigation involving the parties to this Release Agreement shall be brought solely within Alberta and shall be within the exclusive jurisdiction of the Courts of Alberta; and

6. If this Release Agreement is completed electronically or online, then I consent to signing this Release Agreement electronically and confirm that my electronic signature is the legal equivalent of my manual signature in this Release Agreement.

7. If any provision of this Release Agreement is held by a Court to be unenforceable, then such provision will be modified to reflect my and Releasees’ intention. All remaining provisions of this Release Agreement shall remain in full force and effect as drafted.

In entering into this Release Agreement, I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of skiing and snowboarding or the use of the Equipment or other than what is set forth in this Release Agreement.

I CONFIRM THAT I HAVE READ AND I AGREE TO THIS RELEASE AGREEMENT. I AM AWARE THAT, BY SIGNING THIS RELEASE AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES, INCLUDING THEIR RIGHT TO SUE. I ACKNOWLEDGE THAT I AM SIGNING THIS RELEASE AGREEMENT FREELY AND VOLUNTARILY AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.
